If your 2023-2024 FAFSA is chosen for verification, you will be required to submit documentation to the UTA Office of Financial Aid to verify the 2021 income information reported.

2021 Tax Filers:

If you, your spouse (if you are married), and/or your parents (if you are dependent) filed a 2021 federal income tax return, and the Data Retrieval Tool (DRT) was not successfully used when completing the FAFSA, you will be required to submit either:

- 1. A copy of the IRS Tax Return Transcript: https://www.irs.gov/individuals/transcript-types-and-ways-to-order-them); or
- 2. A signed copy of the filed 1040 with schedules 1, 2, and/or 3 copies of returns must be signed by the owner of the return (only one owner if a joint return) or include the preparer's name, address, and SSN, EIN, or PTIN.

2021 Non-Tax Filers:

If you, your spouse (if you are married), and/or either of your parents (if you are dependent) did not file a 2021 federal income tax return, you will be required to submit documentation to confirm the tax filing status and any 2021 earned income as follows:

- I. Dependent student did not file:
 - 1. The 2023-2024 Verification of Income Form Student: https://www.uta.edu/administration/fao/apply-for-aid/forms; and
 - 2. Copies of 2021 W-2's or other acceptable documentation of 2021 income earned.
- II. <u>Dependent student's parent did not file:</u>
 - 1. The 2023-2024 Verification of Income Form Parent: https://www.uta.edu/administration/fao/apply-for-aid/forms;
 - 2. A 2021 IRS Non-Filing Letter: https://www.irs.gov/individuals/transcript-types-and-ways-to-order-them. Before submitting the letter to the UTA Office of Financial Aid, indicate your UTA ID and name on the letter for identification purposes; and
 - 3. Copies of 2021 W-2's or other acceptable documentation of 2021 earned income.
- III. Independent student and/or spouse did not file:
 - 1. The 2023-2024 Verification of Income Form Student: https://www.uta.edu/administration/fao/apply-for-aid/forms;
 - 2. A 2021 IRS Non-Filing Letter: https://www.irs.gov/individuals/transcript-types-and-ways-to-order-them. Before submitting the letter to the UTA Office of Financial Aid, indicate your UTA ID and name on the letter for identification purposes; and
 - 3. Copies of 2021 W-2's or other acceptable documentation of 2021 earned income.
