## UTA PRIORITIES FOR THE 86TH TEXAS LEGISLATURE

#### FORMULA FUNDING

Support consistent funding of the state higher education formulas first, to support increased enrollment and weighted semester credit hour growth, continuing to help hold tuition costs down for students and their families.

#### **RESEARCH FUNDING**


Support increased funding for the Texas Research Incentive Program (TRIP), Governor's University Research Initiative (GURI), and Core Research Fund (CRF), all of which support increased research activity and economic development around Texas' Tier 1 research institutions and enable a stronger and more competitive state.

#### **FINANCIAL AID**

Ensure adequate support for TEXAS (Toward EXcellence, Access, and Success) grants and other critical state investments in financial aid programs that may affect access to higher education for all Texans, in line with the 60x30 plan.

#### RESTORATION OF 2017 BUDGET REDUCTIONS

Restore funding to pre-2017 levels, when the Texas Legislature enacted Senate Bill 1, reducing general revenue funding to The University of Texas at Arlington by \$5.4 million. This reduction came during a period when UTA had grown by 6 percent in FTSE and 4.1 percent in WSCH since the previous reporting period.

#### **P-16 EDUCATION**

Promote funding and legislative changes that would ensure streamlining of education initiatives designed to foster seamless transitions and pathways from early childhood education until completion of a college degree, which would lower costs to the state and students and more effectively graduate an educated workforce to build the Texas economy.

#### **INNOVATION INVESTMENT**

Continue to support funding to promote strategic research collaboration, augment technology transfer and commercialization, and support UTA's goals of increased partnerships with the corporate community, both as a means of economic development and a way of building an innovation economy, thus enabling further advancement as a major national research university.





# NURSING SHORTAGE REDUCTION PROGRAM

Texas' Nursing Shortage Reduction Program (NSRP) has been vital to the growth of UTA's College of Nursing and Health Innovation. Through innovation in online education programs, UTA has dramatically increased capacity while maintaining exceptional quality standards, as demonstrated by a consistent NCLEX firsttime pass rate of greater than 90 percent. We urge the Legislature to continue to fully fund the Texas NSRP and maintain its original purpose to ensure that the demand for highly educated nurses is met as the state's population continues to grow.

#### THE COLLEGE OF NURSING AND HEALTH INNOVATION AND SCHOOL OF SOCIAL WORK ACADEMIC BUILDING

The new facility will combine UTA's Smart Hospital—which is filled beyond capacity and in a small, deteriorating modular building—and the School of Social Work located in a deteriorating building that dates to 1922—to move to a permanent home that meets capacity demands. This new facility will feature a mixture of conventional classrooms, Smart Hospital teaching labs, faculty offices, support staff offices, and student work and research spaces.
