•	Mr. Gunnip will follow up on the issue involving questions being deleted

	forward this inquiry to UTA's technical liaison and have an update for the	
	group next meeting.	
•	Molly Albart asked if there was a way to set up some tree organization	
•	structure within the system.	
•	Brandon Gunnip states yes there is. QuestionPro has a Teams	
•	functionality. We have the capability to create teams and to segregate	
	our surveys so that people only see their needed surveys. Currently we	
	have 6 users utilizing this functionality. Upon request for whoever would	
	like this, Mr. Gunnip will be very happy to facilitate the process or if	
	needed our technical representative can complete this task as well.	

	 Dr. Jared Kenworth asked if there was a way to streamline the login process. He shared that he has to go through five or six different steps just to login. It would be extremely helpful if it could be streamlined as part of a single sign-on. Brandon Gunnip stated we currently have an outstanding request from Douglas Bregere, who's our Enterprise Architect within OIT to examine our configuration settings as far as the login is concerned. If we can get that optimized, it would address many of the concerns related to that. This is considered a functionality issue that must be addressed in order to streamline the use of the tool, so we will be addressing that and will have an update as soon as possible. Dr. Navarro created a team for this group called QuestionPro User Group. Brandon Gunnip reported that it was determined that the Teams Group is the most efficient way to manage the QuestionPro User Group. Dr. Navarro discussed future meeting dates. Dr. Navarro suggested meeting every other month on the third Tuesday to discuss issues. Questions or issues that arise before the meeting can be added to the Teams channel for discussion at any time. The QuestionPro User Group agreed to the proposed meeting schedule.
