# ENTRANCE FLOOR MATS

# PART 1 – GENERAL

# 1.1 PURPOSE

A. This guideline is intended to provide useful information to the Professional Service Provider (PSP) to establish a basis of design. PSP is to apply the principles of this section such that the University of Texas at Arlington (UTA) may achieve a level of quality and consistency in the design and construction of their facilities. Deviations from these guidelines must be approved by UTA and may require justification through Life Cycle Cost (LCC) analysis and submitted to UTA for approval.

# 1.2 LESSONS LEARNED AND DESIGN CONSIDERATIONS

- A. Recessed walk-off mat systems are no longer desirable on campus due to maintenance and service difficulties.

- B. Product Data: Provide data indicating properties of walk-off surface.

- D. Samples: Submit two full size samples, illustrating pattern, color, finish, edging and selected carpet.
- E. Maintenance Data: Include cleaning instructions, stain removal procedures.


