The University of Texas at Arlington College of Nursing & Health Innovation Department of Undergraduate Nursing upholds thehighest ethical standards. Ethical decision-making is of the utmost importance in the profession of nursing and to that end, all students (licensed or not) are expected to maintain the high standards of ethical conduct necessary to ensure accountability for their learning and optimal care of their clients.

As a client-centered practice, the profession of nursing is obligated to develop nursing students into individuals capable of providing culturally competent care based within mutually respectful interactions. Nursing is one of the most respected and trusted professions in society. Students are expected to provide client privacy, confidentiality, and safety, while accepting individual accountability. These ethically centered behaviorspreserve the respect and trust of the public. According to the National Student Nurses Association, "students of nursing have a responsibility to society in learning the academic theory and clinical skills needed to provide nursing care. The clinical setting presents unique challenges and responsibilities while caring for human beings in a variety of health care environments. The code of Academic and Clinical conduct is based on an understanding that to practice nursing as a student is an agreement to uphold the trust with which society hasplaced in us. The statements of the code provided guidance for the nursing student in the personal development of an ethical foundation and need not to be limited strictly to the academic or clinical environment but can assist in the holistic development of a person."
