Instructions for MyMav Transfer of Graduate Courses form

- 1. Official transcripts reflecting the final grade of the requested transfer credit must be on file with the Graduate School on or before the submission date of this form.
- 2. This form must include all the required original signatures, except for the Dean of the Graduate School, before being submitted to the Graduate Office. The form may be delivered in person or by mail to the UTA Graduate School, 333 Davis Hall, Box 19167, Arlington TX, 76019.
- 3. Courses requested must be from an accredited institution, be graduate level, and have a grade of 3.0 or better. The Graduate School does not accept transfer credit that is not given a letter grade. For example, courses graded Pass/Fail will not be approved.
- 4. Course units requested must not exceed 9 units or 25% of total units required for the degree.
- 5. All transfer courses must have the UTA equivalent course listed.
- 6. Only students pursuing the master's degree can request transfer credit. Transfer credit is not allowed at the doctoral level.
