## Instructions for External Committee Member Form

On October 24, 2024, AECAP/MECAP adopted additional qualifications for external committee members because of concerns raised by faculty. These qualifications are listed below:

- 1. The external committee candidate must have experience or expertise relevant to the thesis or dissertation topic.
- 2. The external committee candidate must have earned their Ph.D. a minimum of three years ago
- 3. The external committee candidate has no conflicts of interest with the exam, specifically grant sponsors, family members, former spouses, relatives of the student or committee members, and anyone currently financially supported by the supervising professor.

When submitting the external member request to AECAP/MECAP, in addition to the external member candidate's CV, the applicant should include the following information in the text box on the external committee member form in addition to what is required by the graduate school:

- 1. In the text box, the committee chair should include a statement outlining how the external committee candidate's background is relevant to the thesis or dissertation being defended.
- 2. In the text box, the committee chair should include the following statement verbatim: "The external committee candidate has no conflicts of interest with the exam, including grant sponsors, family members, former spouses, or relatives of the student and committee members."
