Other Business. Michael Moore made the following announcements:

If you look around, you will notice that there are a fair number of people not here. Notice if you have a colleague missing and remind them of the importance of coming.

At the next meeting, there will be more to discuss. We have been assessing our core curriculum requirements. The College of Science will be presenting their findings based on their assessment, both in natural sciences and mathematics. The College of Liberal Arts will be presenting their assessment in the area of Communication.

The SACS visit went extremely well. Thank all of you who were involved in the preparation for that visit. They had very, very few recommendations. They said things like flawless process and they could not say enough nice things about our QEP. We haven't received our final report from them yet. We will get that in a week or 10 days but it is all good news. There will be a few minor things that we will have to clean up. Thank you all for you involvement.

The question was asked if it was still possible to get approval this year to reduce the minimum degree hour requirements. Kimberly van Noort said there were still two meetings of the Undergraduate Curriculum Committee left and one more meeting of the Undergraduate Assembly.

Michael Moore said that if they were approved this year, the requirements could be put in place for next year. It's not a requirement that you go to 120 hours. It's an encouragement. If you can do so without jeopardizing the academic integrity of the degree, it's recommended because your peers are probably going to be doing that as well. If you have accrediting reasons or it's simply not possible and if your peers are not doing it, that's fine. It's not a state mandate. What we don't what to happen is for all your peers to be at 120 hours for your degree program and for you to be sitting at 132. Then you won't be competitive. If you can get it passed in the spring, it would be effective for fall.
