Approval of Minutes. The minutes of the regular meeting on March 11, 2008, were approved as published.

Fall 2008 Convocation. Don Gatzke and Frank Lamas are co-chairs for the Fall 2008 MavsMeet Convocation. They asked for suggestions for improvements and ideas on how to get more faculty to attend. They pointed out that the attendance has increased to about 1400-1600 people but very few faculty attend. The event is an academic ceremony and the one chance at the beginning of the academic year during new student orientation for the institution to let the students know that this is what it's all about – the excitement of ideas and the passion for knowledge. One thing they would like to do is recognize faculty at the convocation but this idea had to be scratched last year due to the lack of faculty attendance. They urged faculty members to attend and to encourage their colleagues to attend the MavsMeet Convocation at 4 p.m., August 22, in Texas Hall.

Collins Watson added that student government heard from a lot of students coming in last September saying they wished there were more faculty at that event. These were mostly students who more academically oriented and were really proud to be at UTA. They were disappointed to attend this great academic oriented event and not see any of their professors. It would really mean a lot to them to have a huge faculty turnout.

Report of the Academic Standards Committee. David Gray presented the following report. Each item was explained, discussed and then approved.

The following items are submitted to the Undergraduate Assembly by the Committee on Academic Standards for consideration at its April 22, 2008, meeting.

Item One – Course Requirement Outside of Class Time

At the request of Michael Moore the committee offers the following non-catalog policy statement concerning faculty teaching responsibilities:

"Faculty members have the academic freedom to determine course objectives and requirements, specify course text and other learning materials, and use various methods of instruction in meeting course objectives. An instructor can schedule an event (field trip, corporate visit, outside lecture, etc.) or course requirement (exam, presentation, etc.) outside the regular class time; however, the time/date of this course event or activity should be indicated in the course syllabus and the instructor should provide one or more alternatives for completion of the course requirement for any student who cannot attend the event or participate in the activity because it is outside the regular class time. When inclusion in the

syllabus is not possible, the faculty member should communicate specific information about the required event or activity as soon as possible."

Item Two – School of Nursing and Grade Exclusion

The grade exclusion policy became effective with the start of the 2006-07 academic year. At that time the School of Nursing elected to not allow (or to limit) the use of grade exclusion for nursing courses; this is indicated on pages 30-31 and 243 of the current catalog. For some reason, the Undergraduate Assembly minutes do not reflect the School of Nursing's position on grade exclusion. Accordingly, the Committee on Academic Standards requests Undergraduate Assembly approval of the School of Nursing's grade exclusion limit as stated on page 243:

"The University grade replacement/exclusion policy is limited by the School of Nursing and is not applicable to nursing courses."

<u>Item Three – Transfer Admission</u>

Currently, prospective students who have attempted college-level courses beyond <u>30</u> hours are considered transfer students (page 12 of current catalog) and those with less than <u>30</u> hours are considered freshman transfers (page 13 of current catalog). A proposal has been made by the Office of Student Enrollment Services to consider prospective students who have attempted college-level courses beyond <u>24</u> hours as transfer students and applicants with fewer than <u>24</u> hours as freshman transfers. Additionally, at the end of the freshman Transfer section (page 13 of current catalog), the following will appear:

"Applicants who have completed at least 12 hours of core courses, including at least 3 hours of math or natural science, in a single semester and have earned a 3.0 grade point average will be admitted upon completion of an application and submission of an official high school transcript and an official transcript of all college work attempted."

Item Four - Honors College Admission Requirement

The Honors College proposes to raise its grade point average admission requirement for continuing and transfer students from 3.2 to 3.35 (page 58 of current catalog).

<u>Item Five – Department of Communication Admission to Major</u>

The Department of Communication proposes admission and degree completion requirements as follows (page 166 of current catalog):

Admission to Major

All undergraduate students seeking to declare a major in the Department of Communication (ADVT, BCMN, COMS, CTEC, JOUR, PREL) must meet the following criteria:

- Successful completion of the Spelling, Grammar, and Punctuation Test with a minimum score of 70%.
- Completion of a minimum of 12 hours in residence at the University of Texas at Arlington with a minimum cumulative GPA of 2.0/4.0.

Students who do not meet these minimum requirements can request to be admitted as a Pre-COMM major according to the conditions below.

Admission as Pre-COMM Major

- Successful completion the Spelling, Grammar, and Punctuation Test with a minimum score of 70%.
- Pre-COMM majors may enroll in up to a total of 18 hours in the Department of Communication (ADVT, BCMN, COMS, CTEC, JOUR, PREL).
- Students who do not achieve a cumulative UT Arlington GPA of 2.0/4.0 by the completion of 18 hours in the Department of Communication will not be cleared to continue in the department.

Dismissal from Department of Communication Pre-COMM status

Students who do not meet the requirements for declaring a Department of Communication major after completing eighteen (18) hours of communication coursework will not be allowed to take additional communication courses at UT Arlington. The student will be suspended from the Department of Communication Pre-COMM status and must choose a major other than Pre-COMM at that time in order to remain enrolled at UT Arlington.

Degree Completion Requirements

- Graduation as a major in the Department of Communication must meet the UT Arlington graduation standard of a minimum GPA of 2.0/4.0.
- Graduation as a major in the Department of Communication must meet the department graduation standard of a minimum GPA of 2.0/4.0 in all department courses (ADVT, BCMN, COMS, CTEC, JOUR, PREL).

<u>Item Six – Admission and Graduation Requirements for CRCJ Major</u>

The Department of Criminology and Criminal Justice proposes admission and degree completion requirements as follows (page 173 of current catalog):

Admission to the Major

Students admitted to UT Arlington from high school or transfer students who have completed less than 30 hours of transferable college credit will be admitted as Criminology and Criminal Justice (CRCJ)-Intended majors, and will be allowed to declare CRCJ as their major based on the following criteria:

- Completed at least 15 hours of the College of Liberal Arts core courses with a minimum 2.0 GPA.
- Completed both CRCJ 2334, Introduction to Criminal Justice, and one other CRCJ core course with at least a C, and earned at least 15 grade points in the two courses combined (2.5 GPA).

Students admitted to UT Arlington who have completed 30 or more hours of transferable college credit will be allowed to declare CRCJ as their major based on the following criteria:

- Achieved a minimum 2.25 GPA for all college credit earned, and
- Completed CRCJ 2334, or an equivalent course, and one other UTA CRCJ core course, or equivalent course, with at least a C and earned at least 15 grade points in the two courses combined (2.5 GPA).

Students already admitted to UT Arlington, who previously declared a major other than CRCJ, who desire to change to CRCJ as their major will be accepted based on the following criteria:

- Completed at least 15 hours of the College of Liberal Arts core courses,
- Achieved a minimum 2.25 GPA in all hours completed at UTA, and
- Completed both CRCJ 2334, Introduction to Criminal Justice, and one other CRCJ core course with at least a C, and earned at least 15 grade points in the two courses combined (2.5 GPA).

Degree Completion Requirements

A total of 54 hours, consisting of 33 hours of required CRCJ core courses and 21 hours of major electives. In addition to fulfilling University and College of Liberal Arts requirements, students planning to graduate with a B.A. in Criminology and Criminal Justice (CRCJ) must also fulfill the following requirements:

- Be a declared CRCJ major,
- Achieve a minimum overall 2.0 GPA in all courses taken at UTA,
- Earn a C or better in all major courses required for the degree, and
- Maintain a minimum of 2.5 GPA in all CRCJ courses taken, including approved electives selected from ECON, HIST, POLS, and SOCI.

<u>Item Seven – Admission and Graduation Requirements for ARCH Major</u>

The School of Architecture proposes the following changes in admission and graduation requirements (page 64 of current catalog):

Applicants must have a 2.8 cumulative GPA in all courses at UT Arlington as well as a 2.8 GPA in all courses within the School of Architecture.

GPA Requirements: Upon admission to the Major Studies, all declared majors must maintain a minimum GPA of 2.5 in both Architecture and in the cumulative GPA to continue in the upper level program to satisfy requirements for graduation.

Grade Requirements: A grade of C or higher must be earned in each School of Architecture course used for credit toward an undergraduate degree offered by the school. A grade of C or higher must be earned in all required Math courses.
