Approval of Minutes. The minutes of the regular meeting on November 4, 2008, were approved as published.

Report of the Academic Standards Committee. Michael Moore gave the following report.

There were three items that were brought to the Academic Standards Committee. Two of which will be covered in the Undergraduate Curriculum Committee Report.

There was a proposal from Architecture to change the requirement in their minors requiring a grade of C or better to earn a minor. They believed this requirement was already in the catalog but it was not explicit and there was some confusion. It was clearly there for majors requirement but it was not clear that this was also applied to minors. The motion was brought to the Academic Standards Committee and approved.

The second one was a similar type motion for the School of Social Work in terms of progressing to the field placement class, a supervision class. A grade of C or better would be required in the classes leading up to that course before they would send a student out into supervision.

Both of those proposals are in the reports for the Undergraduate Curriculum Committee.

The third item we are not reporting out at this time. There has been a request to revisit the grade exclusion language in the catalog. There was a vigorous debate and discussion but we did not have sufficient members to vote on the measure. It was tabled. We may have something for you at the next meeting. If you have comments about that particular issue that you would like to share, Andy Kruzic is a member of that committee as well as myself and you can feed those comments to either one of us. We'd be happy to take them to the committee.

In the Department of Communication and the Department of Political Science we're adding some courses that have to do with the Archer Fellow Program in Washington, D.C., that is run through the Honors College. Karl Petruso, Dean of the Honors College, gave the following summary.

For about eight or nine years, the Archer Program, a UT System sponsored program, has been housed in the Honors College. It provides three courses, one in Communication and two in Political Science, that are taught in Washington, D.C., by UT System faculty who are based there. In addition to those three courses, there is also an internship which is custom designed by the director of the program according to the student's professional, personal, and career plans. It could be on Capitol Hill, with the Supreme Court, with federal agencies and so on. The nice thing for our students is that it provides seamless integration with courses for which they can get UT credit. For many years each component institution numbered those courses in various ways. About a year ago, they decided to standardize them. Basically, we gave them their own dedicated numbers and put them forward with related descriptions given to us by the Archer Center.

Other Business.

Provost Bobbitt gave a summary of the talk he presented at a Focus on Faculty conversation sponsored by the Library. We are meeting the requirements or are on the road to meeting the requirements for consideration for a Tier One institution in almost all regards except one. One area where we, as an institution, are falling down is in our student success metric. He pointed out that our first year retention rate is much lower than other schools with similar demographics. Also our six year graduation rate is not where it should be. I feel this is the last hurdle we have to face in order for us to really be considered in the class of schools to which we aspire. The purpose in my offering these comments to you is to basically start the discussion. I'm interested in hearing feedback from a wide an audience as possible about possible solutions to this problem.

There is a task force which has looked into this and has recently prepared a report with recommendations designed to address some of the issues identified as being contributors to this characteristic. That report is in draft stage. Once it has been reviewed by the president and a few others including the task force itself, it will be

released to the campus community. We certainly not only want but need your feedback and input in terms of that report and what we do next.

One of the things that has been proposed is to create a degree which some people have classified as University Studies. It's different from Interdisciplinary Studies. It draws upon the coursework that they have plus puts some other constraints upon them. It doesn't really prepare them for a profession in any one particular discipline. What it does is make sure they are competent writers, competent communicators and that they can do the mathematics of a college graduate. There are a number of positions such as law enforcement, fire fighters and flight attendants where a college degree is the entrance ticket.

The other thing that is becoming clear is that schools, with student demographics similar to ours, that have faced this, have thought about the freshman year as a very special time, in the sense that we have so many first generation first time college students. These schools have looked at something very similar to a University College. All freshmen come into a University College where the appropriate resources are in place in terms of advising and counseling and other support units to make sure they make it through to their sophomore year. The schools that have entered into this, including UT Austin, have seen fairly significant improvement in first year retention.

That is the gist of a discussion that is coming to the campus. I welcome your input on this matter.
