Proposal for Revisions to the Core Curriculum. David Silva presented the following Proposal for Revisions to the Core Curriculum from the Undergraduate Curriculum Committee.

# Core Curriculum Review <br> Report of the Undergraduate Curriculum Committee 

## Proposal for Revisions to the Core Curriculum

The Undergraduate Curriculum Committee has carefully considered several proposals for urgently needed revisions to the core curriculum and now presents its unanimous recommendation to the Undergraduate Assembly and to the Provost. Each member of the committee solicited feedback several times from their respective units. Input was also solicited from department and program chairs, as well as from the Office of Institutional Research, Planning and Effectiveness, the Office of Records, and the Office of the Provost. This proposal is comprised of two parts, the first addressing alignment of our core components with those of the Texas Higher Education Coordinating Board (THECB) and the second addressing the integration of the proposed First-Year Seminar into the core curriculum.

## Aligning our Core Components - Proposed Adjustments

l. Limit core to 1000 and 2000-level courses

Rationale: In keeping with the spirit of the core curriculum as providing a foundation of core knowledge, which better positions students to succeed in upper-division courses, core courses should be uniformly general in scope and introductory in nature. The committee recognizes that this may result in loss of upper-division SCHs in some areas, but feels that the attendant opportunity to develop new lower-division courses and/or to revisit the level and content of existing courses will provide balance. In addition, the new First Year Experience seminars will generate additional semester credit hours.
2. Replace the "Social and Cultural Studies" component with "Social and Behavioral Sciences."

Rationale: This change will align our core with the components prescribed by the THECB.
3. Allow students to fulfill the lab science requirement with two different sciences (as opposed to the 8 hours in a single lab science).

Rationale: Gaining experience in two different sciences responds to the spirit of the core as a broad and general educational experience. Those programs that place a high value on the deepening of the analytical skills, which typically happens in a second course in the same science, will have the freedom to designate such a requirement as part of their major.
4. Replace the "Literature" component with a more general "Humanities" component.

Rationale: This change will align our core with the components prescribed by the THECB and provide students with options in other humanities disciplines.

## Integration of the First-Year Seminar

As part of a University-wide effort to improve student academic achievement, retention, and degree-completion, several units on campus have successfully piloted First-Year Seminars (FYS), with other units planning to begin offering new sections of an FYS in Fall 2010. Based upon a thorough review of results of such seminars both on campus and at aspirational peer institutions, the Curriculum Committee recommends that the FYS be integrated into the core curriculum at UT Arlington. The committee recommends that the FYS become one of the two "local options" available to our core and that the second option be either an additional 3-hours of Mathematics/Quantitative Analysis OR 3 hours in a Liberal Arts elective at the 1000 or 2000 level. The choice of the second option will be the purview of individual programs.

The Undergraduate Assembly considered each recommendation separately. Sections 1, 2, and 4 were approved unanimously. Section 3 was approved with one opposition.

During discussion of the Integration of the First-Year Seminar, a motion was made to change the second option to "either an additional 3 hours of Mathematics, Science or Engineering OR 3 hours in a Liberal Arts elective at the 1000 or 2000 level." After additional discussion, the motion was withdrawn.

Instead a motion was approved to table and return the Integration of the First-Year Seminar to the Undergraduate Curriculum Committee to explore the feasibility of changing the second option to 3 hours of Environmental/Sustainability courses. Dr. Silva said that as long as it was approved and sent to the Coordinating Board by January, then the new requirement would be effective beginning Fall 2011.
