### Fall 2020 Planning

The subgroup on **Identifying Class Modality** finalized a <u>definition of modalities</u> that the campus will use for Fall 2020 planning. The modality types help inform space needs, and the subgroup took into account pedagogy, equipment/instructional requirements, as well as student success efforts. Additional resources to understanding these modalities are offered to faculty via a table and graphic on the <u>Faculty Resource page</u>.

The **subgroup on Facilities and Classroom Scheduling** is finalizing a first complete draft of the fall 2020 course schedule with new modalities. Colleges/schools submitted their request June 1 and have until Friday, June 12 to correct any errors. The courses will be listed for students to use as they enroll under three basic modalities: online, F2F and hybrid. Colleges/ schools will be asked to submit specifics on the type of hybrid modality mid-June.

The **Logistics and Training Committee** is advertising small group sessions with instructional designers to support faculty changing the modality of their courses. **Faculty must complete the trainings on teaching tools** (Canvas, Teams or Echo 360) before enrolling in these sessions. # **Faculty Survey**

The Fall 2020 Planning subgroup on Faculty Issues completed a survey that was administered from May 22 to June 1, 2020. A total of 685 faculty completed the survey and more than 4,000 comments were received for the open ended questions, The subgroup is analyzing this data to inform its recommendations to the Fall Planning Task Force. Findings suggest:

- 44% of respondents feel they are at higher risk of Covid-19 illness or complications, and 24% are caregivers for a person at higher risk of illness.
- 77% strongly agree or agree that students should only be allowed in the classroom if they wear a face mask.
- 73% strongly agree or agree that the university communicated changes effectively in response to the Covid-19 pandemic.
