## PLACE OF EMPLOYMENT (POE) APPLICATION

## **Option 1: Traditional**

The student works at a social work agency, but their role does not align with the student's level of learning (BSW / MSW). The student's place of employment can provide new opportunities significantly different from the student's current roles and responsibilities. The student's place of employment will allow the student to engage as a learner in a new department or area and fulfill the following field education requirements:

- Activities align with the 9 CSWE Competencies.
- Activities align with the student's BSW or MSW learning contract.
- Activities align with student specialty if an Advanced MSW student: Aging, CAP, Children and Families, Health, or Mental Health/Substance Abuse.
- Provide the student with a qualified Field Instructor who will supervise the student and provide 1-hour weekly supervision outside of the student's work hours.
- Be affiliated with UTA's School of Social Work.

### **Qualified Field Instructor Requirements:**

- 1. The individual holds a BSW or MSW degree from a CSWE accredited school and has two years of post-degree Social Work experience.
- 2. Individuals with a BSW can only supervise BSW students.
- 3. Individuals with an MSW can supervise BSW and MSW students.
- 4. The agency must provide a qualified field specialist.

#### Disclaimers:

All students opting into a POE option must complete the POE Form, which must be returned to the student's Field Education Specialist for review to determine whether the request should be approved or denied.

If the agency is not affiliated with UTA, the affiliation process must be completed before the start of the respective field semester. Otherwise, your POE request will be denied.

If you are separated from your placement of employment (voluntarily or involuntarily) during your internship, your field placement will be put on hold, and you must reapply for field for the following semester.

You may be entitled to know what information UT Arlington (UTA) collects concerning you. You may review and have UTA correct this information according to procedures set forth in UT System BPM #32. The law is found in sections 552.021, 552.023 and 559.004 of the Texas Government Code.
