APPLYING FOR THE HAZLEWOOD EXEMPTION

Eligibility Requirements

First Time Veteran Requirements:

(Applies if you are the Veteran AND the student)

- ☐ Reside in Texas
- ☐ Provide DD-214 showing the following:
 - Served at least 181 active duty (not including training)
 - Home of Record or Place of Entry in Texas
 - Character of service (Discharge) honorable or general
- ☐ Provide VA Certificate of eligibility or letter of exhaustion (if veteran served after 09/11/2001)
- ☐ Printout total hours used from the **Hazlewood Database**
- ☐ Complete [UTA's Hazlewood](https://uta.edu/vets) application form (uta.edu/vets) and upload all required documents

Eligibility Requirements

First Time Legacy Requirements:

(Applies if you are the child of a qualified Veteran)

- ☐ Child of a qualified Veteran
 - ☐ Be under 26 years old
 - ☐ Be classified by UTA as a Texas resident
 - ☐ Provide Veteran's form DD-214
 - ☐ Provide proof of dependency to the Veteran
 - ☐ Provide proof of eligibility, ineligibility, or exhaustion, for the student, if any Federal VA Educational Benefits are/were being used
 - ☐ Printout of total hours used from the **Hazlewood Database** for both the Veteran and the student
 - ☐ Complete [UTA's Hazlewood](https://uta.edu/vets) application form (uta.edu/vets) and upload all required documents
- Only one person may use the Veteran's hours at a time.
 - Veteran must reside in Texas while the benefit is being used.

Eligibility Requirements

First Time Dependent Requirements:

(Applies if you are the child or spouse of a 100% disabled or service-connected deceased Veteran)

- ☐ Child or spouse of a qualified 100% permanently & totally disabled or service-connected deceased Veteran
- ☐ Provide Veteran's form DD-214
- ☐ Provide VA disability rating letter at 100% permanent & total or VA form DD1300 for deceased veteran
- ☐ Provide proof of dependency to the Veteran
- ☐ Provide proof of eligibility, ineligibility, or exhaustion, for the student, if any Federal VA Educational Benefits are/were being used
- ☐ Printout of total hours used from **Hazlewood Database** for the student
- ☐ Complete [UTA's Hazlewood](https://uta.edu/vets) application form (uta.edu/vets) and upload all required documents

How to apply for Hazlewood

If you believe that you meet the requirements, please follow the steps below. The application portal will be available to you 24-48 hours after you enroll in classes.

STEP 1

Go to Veteran Benefits Certification page. Click on Hazlewood Exemption tab.

Hazlewood for Veterans: (Must reside in Texas while using benefit)

- DD-214 showing discharge (Member 4 copy)
- [Application form](#)
- VA letter of exhaustion (NOT ebenefits page) if possibly eligible for 100% Ch. 33 benefits or last used Ch. 31 benefits
- VA Certificate of Eligibility if veteran served on or after 9/11/2001. COE may be obtained by completing an application on [vets.gov](#)
- Printout of hours used from the [Hazlewood Database for Students](#)
- Active duty orders needed if residing out of state

**Access to this form is granted once you are admitted & registered for class!*

Hazlewood Legacy: (Must be under 26 years old & meet the school's in-state residency requirements) *Only one person at a time may use the Veteran's Hazlewood hours.*

- Veteran's DD-214 showing discharge (Member 4 copy)
- [Application form](#)
- Proof of eligibility, ineligibility or exhaustion, *for the student*, if any Federal VA Educational Benefits are/were being used (if the veteran served on or after 9/11/2001). Certificate of Eligibility may be obtained by completing an application on [vets.gov](#)
- Proof of dependency (i.e. birth certificate)
- Both Veteran and Dependent printout of Hazlewood hours used from the [Hazlewood Database for Students](#)
- Active duty orders needed if Veteran is residing out of state

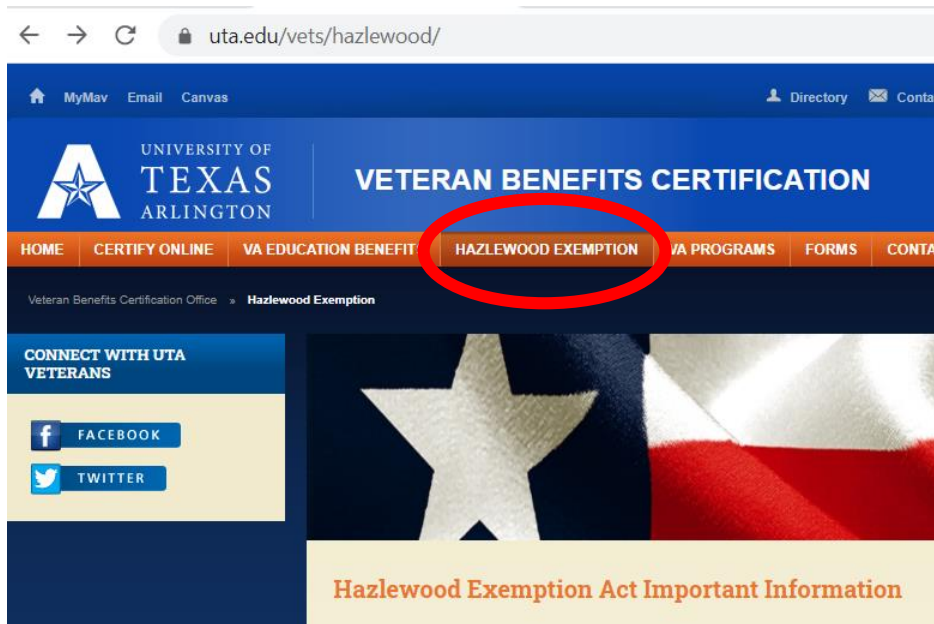
Continued Hazlewood Veteran, Legacy, and Dependent Exemption users' requirements:

- ☐ Must meet UTA's Satisfactory Academic Progress requirement
