

**FIRST AMENDMENT TO DUAL CREDIT PARTNERSHIP AGREEMENT BETWEEN
ARLINGTON COLLEGE CAREER HIGH SCHOOL AND THE UNIVERSITY OF
TEXAS AT ARLINGTON**

This First Amendment (“**First Amendment**”) to the Dual Credit Partnership Agreement between Arlington Independent School District on behalf of Arlington College Career High School (“**School**”) and The University of Texas at Arlington (“**University**”) is made and entered into as of June 14, 2023 (“**Effective Date**”).

RECITALS

WHEREAS, University and School entered that certain Dual Credit Partnership Agreement with an effective date of June 14, 2022, (“**Agreement**”).

WHEREAS, University and School now desire to amend the Agreement to extend the term.

NOW THEREFORE, in consideration of the promises and other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledge by each party, University and Contractor agree as follows.

AGREEMENT


1. Section 1.a of the General Provisions is deleted in its entirety and replaced with the following:

“a. The term ("Term") of this Agreement will begin on the Effective Date and shall be in effect for two (2) years. The Agreement may be renewed for additional years by mutual written agreement of the Parties.”
2. This First Amendment embodies the entire Agreement between University and School with respect to the amendment of the Agreement. In the event any conflict or inconsistency between the provisions of this First Amendment and the Agreement as previously amended, the provisions of this First Amendment will control and govern.
3. Except as specifically modified and amended herein, all of the terms, provisions, requirements and specifications contained in the Agreement remain in full force and effect. Except as otherwise expressly provided herein, the parties do not intend to, and the execution of this First Amendment will not, in any manner impair the Agreement, the purpose of this First Amendment being simply to amend and ratify the Agreement, as hereby amended and ratified, and to conform and carry forward the Agreement, as hereby amended, in full force and effect.
4. This First Amendment will be construed and governed by the laws of the State of Texas.
